LAKESIDE'S SECOND CROSS-ISLAND WALK

As part of the **4ward Together 4 Million Steps** fundraising campaign for our work serving 4000 (ex-) inmates and their families, our Executive Director, Mr Teo Tee Loon, led a group of supporters on a 40km Cross-Island Walk on 26 November from Lakeside to Changi Prison! We were honoured to have Guest-of-Honour, Mr Shawn Huang, Member of Parliament for Jurong GRC, grace the event and walk with us from start to finish!

As a sign of our commitment to walking the long journey of recovery and reintegration with our beneficiaries, 28 supporters completed the 12-hour walk across the island, achieving close to **1.5 million steps overnight!** We deeply appreciate everyone's support and dedication.

We have raised **\$138, 407** as of 7 December will continue to collect donations for 4ward Together 4 Million Steps until **31 March 2022**. With your support, we hope to raise **\$300, 000**.
